

BY-LAW NO. 2024-008

BEING A BY-LAW TO PROVIDE FOR THE ADOPTION OF TAX RATES AND TO FURTHER PROVIDE FOR PENALTY AND INTEREST IN DEFAULT OF PAYMENT THEREOF FOR 2024.

WHEREAS Section 312 of the Municipal Act 2001 as amended provides that the Council of a local municipality shall after the adoption of estimates for the year, pass a By-Law to levy a separate tax rate on the assessment in each property class;

AND WHEREAS Section 312 of the said Act require tax rates to be established in the same proportion to tax ratios; and whereas Council has set tax ratios by By-Law No. 2024-007;

AND WHEREAS Council for the Corporation adopts the 2024 levy for municipal purposes as \$475,603.38 per the attached budget.

AND WHEREAS certain education rates are provided in various regulations and commercial and industrial education amounts have been requisitioned by the Province;

NOW THEREFORE, the Council of the Corporation of the Municipality of Mattawan enacts as follows:
