

Application to update, add or remove information from the voters list



Eligibility & requirements

This application can be submitted by email or mail to update, add or remove your information, from the voters list maintained by Elections Ontario, based on your home address. You can also register online at vReg.RegisterToVoteON.ca.

This application can be used to request that your information be:

- updated on the voters list (if your name and/or home address has changed);
- added to the voters list; or
- removed from the voters list or the Ontario Register of Absentee Voters.

To be eligible, you must be:

- 18 years of age or older;
- a Canadian citizen; and
- a resident of Ontario.

You will need to submit one piece of ID showing your name **and** home address. The information on your ID must match the information you are submitting.

Legal name change requirements

To change your legal name, including the use of a spouse or partner's name, you must provide the following **two pieces of ID**:

- A marriage certificate or a change of name certificate issued by a provincial/territorial registrar **and** one piece of ID showing your current name and home address;

OR

- One piece of ID showing your previous name and home address **and** one piece of ID showing your current name and home address.

ID includes most documents issued by the Government of Canada, the Government of Ontario or a municipality in Ontario.

Important information

Eligible electors who remove their information from the voters list can still vote, but they will:

- not receive a voter information card when a provincial election is called in their electoral district; and
- need to register directly with their municipal or district social services administration board (DSSAB) election administration when a municipal or DSSAB election is called in their area.

Current and temporarily absent residents of Ontario who are Canadian citizens and over 18 years of age are eligible to vote in provincial elections based on the electoral district in which their home address is located.

Current residents of Ontario who are Canadian citizens and over 18 years of age are also eligible to vote in municipal, district social services administrative board (DSSAB) and/or school board elections based on their home address. DSSAB elections are only carried out in unorganized territories in Northern Ontario that are not part of a municipality.

Elections Ontario is committed to protecting the privacy and security of personal information. Information collected and maintained by Elections Ontario is used for electoral purposes only under the provisions of the *Election Act*.

ID requirements for updating, adding or removing your information from the voters list

To update, add or remove your information from the voters list, you must include one piece of ID showing both your name **and** home address. Ontario health cards, citizenship cards or passports do not include your address and are **not** valid ID for registration purposes.

Examples of government-issued ID

- Any document issued by the Government of Canada/ Ontario showing both name and home address
- Ontario driver's licence
- Ontario motor vehicle permit (plate or vehicle portion)
- Ontario photo card
- Property assessment notice from Municipal Property Assessment Corporation (MPAC)
- Child tax benefit statement
- Income tax assessment notice
- Social Insurance Number confirmation letter
- Statement of Employment Insurance Benefits Paid T4E
- Statement of Old Age Security T4A (OAS)

Examples of other accepted documents showing both name and home address

- Any document showing both a person's name and home address issued/certified by:
 - a municipality;
 - a government agency;
 - a court in Ontario; or
 - a Band Council in Ontario established under the *Indian Act* (Canada)
- Document showing campus residence issued by the office or officials responsible for student residence at a post-secondary institution
- School admission letter
- School transcript or report card
- Tuition/fees statement
- Bank account or credit card statement
- Cancelled personalized cheque
- Cheque stub, pay receipt or T4 issued by a person's employer
- Insurance statement
- Residential mortgage, lease, or rental statement
- Signed loan or financial agreement with a financial institution
- CNIB card or a card from another registered charitable organization that provides services to persons with disabilities
- Hospital records showing a person's name and home address
- Letter of Confirmation of Residence
- Utility bill (hydro, water, gas, telephone, cable TV, public utilities commission)
- Property tax assessment or bill from a municipality in Ontario
